Winter Storm - January 9, 2024

A significant winter storm is anticipated to impact Eastern North Carolina on Tuesday, Jan. 9, 2024 beginning in the afternoon hours and lasting into the early morning hours of Wednesday, Jan. 10, 2024.

Please use extreme caution as this storm moves through our area. Strong Extreme winds (70-80 mph) are forecast to begin impacting our area this afternoon around 2 p.m.

Tornadic activity is possible along with coastal flooding.

As a result, CCPS will operate on a two-hour delay on Wednesday in order to give maximum daylight and safety for buses traveling in the early morning hours.
