A freeze on funding for NC Department of Transportation projects will present delays for some of our infrastructure projects, but we will continue to move forward where we can. We know that we have collapsed sewer and storm water systems that are degrading the quality of Beaufort waterways. This underground infrastructure work is going to be difficult, time consuming, and expensive, but is critical to the health and prosperity of our town. Board of Commissioners

During the Aug. 10, 2020 regular monthly meeting, the Board of Commissioners took the following actions:

• Approved minutes for the June 8, 2020 meeting, June 15, 2020 budget work session and the June 22, 2020 work session.

• Approved FY21 Budget Amendment #1.

• Approved the Order for Carteret County to Collect Taxes for 2020.

• Approved amendments to the Personnel Policy.

• Approved the Town Manager to notify the NCDOT the town does not have interest in the ROW property on the south side of Cedar Street.

The Town of Beaufort has the following vacancies on the Historic Preservation Commission (HPC), Board of Adjustment (BOA) and Parks and Recreation Advisory Board (P&R):

HPC—one position to fill an unexpired term ending in January 2021. BOA—one position for an in-town alternate unexpired term ending in January 2022. P&R-three positions for three year terms The Planning Board met on Aug. 17 and discussed the following ending in September 2023.

Historic Preservation Commission

The Town of Beaufort Historic Preservation Commission met Aug. 18 and discussed the following items:

• Case # 20-15 513 Front Street-Exterior Paint: Request to paint exterior a grey/blue as approved from the State Historic preservation Office. Tabled until September meeting for the applicant to consider a softer exterior shade of the proposed color. • Case # 20-06 122 Front Street-Installation of a fence: Request to install a Beaufort style fence along the rear of the property along the seawall at a height not over 48 inches (4 feet). Approved as presented.

• Historic Standards Update-Our consultant provided a first draft to staff and the State. Initial comments have been made. The next draft is expected in September and will be shared with the Commission. A draft for the community should be available in October with a comment and review period.

New Payment Option for Utility Bills and Permits: Web Inquiry and Payment Portal (WIPP)

There is a new way to check your balance and pay your bill online. From the town website www.beaufortnc.org, select Residents, Pay My Utility Bill, then scroll down and click the link for WIPP. Using your account number and PIN (printed on your bill, you can check your balance, see your last three bills, and pay by debit or credit card, or by e-check. There is a convenience fee of 2.95% for debit/ credit, and \$1.05 for e-check. There is not a transaction amount lim-it. To pay an invoice, go to the WIPP page using the instructions above. You will need to have your customer ID and PIN, which is printed on your invoice. If you are used to paying through Official Payments, we think you will find WIPP to be a more enhanced service. Please start using WIPP for your online payments, as we will be transitioning away from Official Payments over the next few months. Official Payments will still be the method to use for IVR (over-the-phone) payments. If you have any questions, please email billing@beaufortnc.org.

Board of Adjustment

The Board of Adjustment met on July 27 and made their finding

on the following item:

Case # 20-01 800 Ann Street: Request for 3 variances: 16.4' encroachment from Ann Street; a 6.32' encroachment from Marsh Street; and a variance from the 50% impervious surface requirement in the RS-5 Zone to an increase of 54.25%. Fats. Oils & Greases

Many overflows, or SSO's, are caused by the accumulations of fats, oils, and greases (FOG) in the wastewater collection

system. While the collection system is designed to handle and safely transport sanitary waste to the wastewater treatment plant, too much FOG placed into the system can cause clogs and result in an overflow, especially after high flow events such as heavy rains. Dumping fats and oils derived from animal and vegetable sources, including meats, nuts,



cereals, and beans, down any drain, in either a home or business, can cause a stoppage that forces raw, untreated waste to spill into our yards, streets, and streams. The Town has adopted a sanitary sewer ordinance in an attempt to reduce the frequency of grease-related overflows.

The 2020 Census An Urgent Call to Action

The 2020 Census is at a critical moment. This count determines North Carolina's federal funding and representation for the next 10 years.

And yet, with little time left, our state is severely undercounted. With only one month left in the process, nearly 40% of North Carolina has not responded to the Census. With our current count, we will lose \$7 billion each year for the next 10 years.

Every single response to the 2020 Census is an estimated \$18,000 to North Carolina over the next decade. That is funding for roads, early education, rural development, veterans, senior care, emergency response services, and parks. Respond today at my2020census.gov or 844-330-2020.

Your responses to the 2020 Census are safe, secure, and protected by federal law. They cannot be used against you by any government agency or court in any way.

The questions are straightforward. No individual data can be reported to any government agency. Title 13 of US law protects your personal census information for 72 years.

DownEast Beaufort Center for Women's Ministries


2020 has been challenging for all of us.
