FY20 STREET REHABILITATION AND CONSTRUCTION

ADVERTISEMENT FOR BIDS

Sealed Bids from qualified Bidders for the **FY20 STREET REHABILITATION AND CONSTRUCTION** will be received by the Town Engineer of the Town of Beaufort at the conference room, Town Hall, 701 Front Street, Beaufort, NC until 2:00 pm Eastern Standard Time on Tuesday, March 3, 2019, at which time they will be publicly opened and read.

The Work to be performed under the Contract includes the rehabilitation of seventeen street segments totaling 8,300± linear feet (LF) through a combination of patching, mill-patching, milling, and the placing of asphalt surface courses; reconstruction of seven street segments totaling 7,000± LF by cement stabilization of the bases and subsequent placement of asphalt surface courses; construction of a new, 410± LF Town street along with turn lanes within a NCDOT-maintained right-of-way; construction of 380± linear feet of new pavement, replacement of 240± LF of gravity sewer, and construction of stormwater improvements at a Town-maintained dirt lane; and reconstruction of a 590± LF street within the Historic District to include replacement of 520± LF of gravity sewer, 590± LF of water main, and 595± LF of stormwater piping along with the placement of 540± square yards of permeable concrete and 1,600 ± square yards of asphalt surface course.

Bids will be received on Single Prime contract basis. Bids shall be on a lump sum and/or unit price basis.

The Bidding Documents may be examined and/or obtained at Town Hall located at 701 Front Street, Beaufort, NC 28516. Partial sets of Bidding Documents will not be available. The Town of Beaufort will not be responsible for full or partial sets of Bidding Documents, including any addenda, obtained from other sources.

Electronic copies in Adobe format of the complete contract documents may be obtained from the Town at no charge. Complete, hardcopy versions of the Contract Documents may be obtained from the Town after receipt of a \$75.00 non-refundable deposit per set. Deposits will not be refunded. Persons requesting shipment of documents shall bear the additional, non-refundable cost of shipment. All checks are to be made payable to the Town of Beaufort.

Bid and Contract securities shall be provided in accordance with Articles 10 and 23 of the Instructions to Bidders.

The Town of Beaufort will conduct a Pre-Bid meeting at Town Hall, first floor conference room, on Wednesday, February 12, 2020 at 2:00 pm immediately followed by a site visits if requested by the prospective Bidders attending.

Bidders shall provide proof of qualifications to perform the Work as described in Article 5 of the Instructions to Bidders.

Bidders must be properly licensed under Chapter 87 of the North Carolina General Statutes and under Municipal Code 11-9.

The Town of Beaufort reserves the right to waive any informalities, to reject any or all bids, and to accept that Bid or Bids which appear to be in the Owner's best interest.

The Town of Beaufort is an Equal Opportunity Employer and Service Provider and encourages participation by small-, minority-, and female-owned firms. Bidders must make positive efforts to use Small or Minority Business enterprises. All qualified Small and Minority businesses are welcome to submit a bid.
